## Buyer beware - Lipstick on a pig.

As many of you may or may not know, on December 20, 2022, I purchased a 1969 Malibu that someone had started to restore as a SS clone. The car caught the eye of myself and my wife as one that could be a fun project.





The car was located in Babylon, NY.

I spent hours talking to the owner, asking questions such as;

- Does the car run and drive?
- Are the floors, both in the cab and the trunk in good shape?
- 10 bolt or 12 bolt rear axle?
- Original interior, engine, transmission?
- Other than the paint, what additional work had been done to the car.

I received the following answers;

• Yes, the car runs and drives. He drove the car to the paint shop and in and out of storage.





- The floors have been patched.
- 10 bolt rear axle, appears to be the original
- Removed bench seat, and put in bucket sears.
- Added SS wheel trim, SS badging.
- He also added that the car is a column shift car, however it comes with a console and horseshoe shifter.

I received enough information during our conversations that I was really interested. It sounded like a project that I would enjoy finishing. So, I did a little digging and found a person who did car inspections from the same town where the car was located. I contacted the inspector, provided the individual with the same list of questions, relying on the fact they had done car inspections in the past and felt confident they could answer my questions after they inspected the car.

The inspector responded stating the car met all of my criteria and it would be a good purchase. Based on the report from the inspector, I negotiated a final price, made payment, and set up shipping.

The car arrived on December 22, 2022, at dusk, I knew I was in trouble when the car would start, but as soon as it was put into gear, it would die. We had to push the car out of the trailer onto the street. Once out of the trailer, I paid the transporter so he could get on down the road. I was able to get it running good enough to get it to the garage. Now the real story begins.

I first started to determine if the car would even run. Ran a compression check only to find two cylinders with zero compression. So how could a person sell a car as a runner/driver when the engine is basically dead. Even if it had been a good running engine, the gas tank was so rusty, it would not have been able to hold fuel, just adding to what was to come.

From there I started stripping the car only to find that it was in really bad shape (rusted). The seller stated the floors were patched, however, my definition of patched was much different than the seller's. I thought new floor pans, for the seller it was the use of aluminum tape covered with a skim of bondo and a thick black paint job to cover it all up. That was just the beginning. The pictures below shows the mount point just behind driver side where the floor and crossmember we completing gone due to rust.









I kept on working hoping to make the best of a bad situation until I got to where the A-pillars were all rusted away. At this point my list of replacement parts was frame, trunk pan with crossmembers, floor pan with crossmembers, A-pillars, a driver's door, radiator core support, engine, and transmission. It was much more than I had equipment to perform the needed repairs. This car was the best definition of putting "lipstick on a Pig" that I have ever seen. It was at this point I decided to cut my losses and prepare for a much better opportunity in the future.



In closing here are a few things that I walked away with in hopes of never experiencing again. I hope you find this helpful.

- Remember the "inspector", don't use an inspector find someone that will do a pre-purchase appraisal.
- Be specific with your questions so you will hopefully get answers that will help you make your decision on whether to purchase or not.
  - One example could be, instead of asking "if the car runs and drives", ask "would you get in the car with your family and take the car on a 100-mile road trip?"
  - Are the floors original or have they been replaced with complete replacement floor pans?

The best piece of advice I can give is to go look at the car yourself, I could have saved myself lots of time and money if I had flown to New York.
